**INCA JOJOBA OIL LITE ORGANIC DEODORIZED** is certified analogue to EU, NOP and JAS-Standards. The seeds are grown on certified plantations in Peru. Processing is made in certified production sites in Panama. The product corresponds to the requirements of regulation (EC) no. 2018/848 in conjunction with regulation (EC) no. 889/2008 and regulation (EC) no. 1235/2008. The ingredient of this product is 100% Jojoba seed oil.

**INCA JOJOBA OIL LITE ORGANIC DEODORIZED** is a 100 % Jojoba Seed Oil, carefully deodorized by submitting the product to moderately high temperatures and deep vacuum. As a result this Jojobaoil is odorless. Manufactured in Panama.

**Production:** Cold pressing of the seeds of the Jojoba shrub, careful physical bleaching with Tonsil and deodorizing under moderate temperature and deep vacuum.

**Chemical and physical properties:** Jojoba oil is a wax and is composed almost completely (97%) of wax esters of monounsaturated, long-chained fatty acids and alcohols with high-molecular weights (C<sub>16-26</sub>). These wax esters are principally (83%) compounds of C<sub>20</sub> and C<sub>22</sub> unsaturated acids and alcohols. Total free acids (C<sub>16</sub> to C<sub>24</sub>) and total alcohols (C<sub>16</sub> to C<sub>26</sub>) each account for 1% of the composition of Jojoba Oil. Mixed tocopherols and free sterols (< 0.5%) are also present. Jojoba oil is very resistant to oxidation and remains chemically unchanged for years (CTFA).

**Appearance/form/odor:** At temperatures > 10.6°, liquid wax of transparent aspect and clear colour as well as odorless. Below this temperature, haze and opacity may appear due to the solidification of the phospholipids. Below 7°C, the product becomes a solid wax. At higher temperatures, the solid wax becomes liquid again. This process has no influence on the quality of the product. Odorless.
