INCA JOJOBA OIL LITE ORGANIC DEODORIZED is certified to EU, NOP and JAS-Standards. The seeds are grown on certified plantations in Peru and processed in certified production sites in Panama. The product corresponds to the requirements of regulation (EC) no. 2018/848 in conjunction with regulation (EC) no. 889/2008 and regulation (EC) no. 1235/2008. The ingredient of this product is 100% Jojoba seed oil.

Production: Cold pressing of the seeds of the Jojoba shrub, careful physical bleaching (filter clay), deodorisation (moderately high temperatures and deep vacuum). As a result, this organic Jojoba oil is colourless and odourless.

Chemical and physical properties: Technically, Jojoba oil is a liquid wax, composed almost entirely ($\approx 97\%$) of wax esters formed from monounsaturated, long-chain fatty acids and alcohols with high molecular weights (C16–26). Most of these wax esters ($\approx 83\%$) consist of C20 and C22 unsaturated acids and alcohols.

Minor components: Free fatty acids (C16–C24) and free alcohols (C16–C26), each $\approx 1\%$ of the total composition; trace amounts ($< 0.5\%$) of mixed tocopherols and free sterols.

Due to its unique wax ester structure, Jojoba oil is exceptionally resistant to oxidation and remains chemically **stable** for years, distinguishing it from most conventional vegetable oils (CTFA).

Appearance/form/odour: At temperatures above **10.6 °C**, Jojoba Oil Lite Organic appears as a clear, transparent liquid wax without colour, without odour. Below this point, a slight haze or opacity may occur due to the partial solidification of phospholipids. At **7 °C and lower**, the product solidifies into a wax. Upon reheating, the solid wax returns to its liquid state without any loss of quality.

Shelf Life and Storage: The product is stable for a minimum of 24 months under standard storage conditions. Under these conditions, the oil remains within specification and safe for intended use.
